Discussion Item

Initial Review of Proposed Budget FY 2025-26 and 2026-27

Documents provided to Board prior to meeting: Staff Memorandum; RHCTF Proposed Budget Carvn Bortnick, SFERS Chief Operating Officer, introduced this item.

Ms. Bortnick noted that the Mayor's office has instituted a hiring freeze and a ban on overnight travel. The proposed travel budget has not been reduced, but any overnight travel will need approval from the Mayor's office in advance. Ms. Bortnick also noted that the budget instructions asked departments to reduce their budgets by 15%. Ms. Bortnick said the greatest reduction was found in the reserves for professional services..

Commissioner Petrucione asked the proposed total budget for the next fiscal year. Ms. Bortnick said she would give them the total budget amount at the next meeting.

Commissioner Casciato asked if there were other reductions besides professional services. Ms. Bortnick responded that reductions were made to the training and education budget and travel expenses, but most of the reductions were from reserves designated for professional services.

Commissioner Salem asked about the increase in spending for the City Attorney's office and whether that was because the RHCTF was ramping up investments. Ms. Bortnick confirmed.

Commissioner Salem asked about the election expenses. Ms. Bortnick responded that there was no expense last year because we did not have an election. Ms. Bortnick noted that there was \$100,000 in the budget if an election was needed and that the San Francisco Department of Elections updated their cost estimate of running an election to \$100,000.
